Tax Rates Page

This page provides the tax rates for:

- 1) The current month.
- 2) The upcoming month.
- 3) Past months.

There are two kinds of documents: the Tax Rate Sheet and the Tax Rate Sheet with Zip Codes. Both documents provide tax information for general sales tax and for alcoholic beverages. General sales tax is listed on the first tab and the alcoholic beverage tax is listed on the second tab of the spreadsheet.

The data sheet only provides information on USPS ZIP codes that are within an ARSSTC member’s boundaries. We do not provide information on USPS ZIP codes that are in non-taxable or non-member districts.

1. USPS ZIP code.
2. State where ZIP code is in.
3. County/Borough where ZIP code is in.
4. Jurisdiction code for county/borough if applicable.
5. City where ZIP code is in.
6. Jurisdiction code for city if applicable.
7. Defines if the ZIP code is within the taxable boundaries (I) or outside the taxable boundaries (O).
 - a. If a ZIP code is larger than a taxable boundary, the ZIP code will be listed twice, once with an I and once with an O in this column.
 - b. In these cases, the ARSSTC recommends using the [tax map lookup](#) for the specific address to determine if it is within the taxable boundary.
8. Sales tax rate at state level (not applicable in Alaska).
9. Sales tax rate at county/borough level.
10. Sales tax rate at city level.
11. Sales tax rate at local level (not applicable in Alaska).
12. Total tax rate for jurisdiction.
13. Date to implement listed tax rate.
