Jeff: working on AGFOA agenda. Reception Wednesday at 5:30. Possibly 7:30-8:00 with catered breakfast? Stephanie: managers Monday, Tuesday. Would prefer in person if possible.

Scott: attorneys' Monday, Tuesday.

Jeff: quorum issues? Change bylaws to consider quorum of members present. Prefer in person.

Clinton: did not do that in the past year. Need vote of members.

Jeff: we can do that this year and fix bylaws.

Stephanie: Tuesday night a possibility?

Jeff: not sure of other AGFOA participant travel, need to do both in-person with and Zoom

Stephanie: representative from community will be allowed to participate in voting

Wednesday 12/7/2022 7:30-8:00 with ARSSTC catered breakfast, move annual update to November stand alone meeting. At December meeting: do elections, bylaws update – Karl to update. Need to update requirements to updating bylaws - Board or entire membership? Keep to entire membership.

Board Terms ending in 2022: Brandi, Melissa, Joan – Clinton to send nomination forms, Jeff to step down and nominate replacement (runs through 2023).

Board Terms ending in 2023: Stephanie, Scott, Xavier

### d. Service Agreement renewal

Signed January 2020. Reaching end of 3-year term. Amendments or revisions?

Jeff: do we want to renew for one year or longer? Prefer longer contract than one year.

Stephanie: need to read agreement Melissa: need to read agreement Brandi: please send agreement

Joan: does longer agreement help AML with pricing advantages and contract negotiations?

Jeff: ARSSTC now running by skilled staff, and board is running as tangential since most policy resolved

Scott: any other issues we need to address or just renewal terms with AML?

Jeff: possibly could find a vendor through an accounting firm. Might lose partnership with statewide organization, lose control of costs.

Need board meeting with new board members to determine contract renewal. January meeting.

#### 6. Financial Update

Audit is scheduled for wrap up in November. Total income for ARSSTC over \$100,000 more than budgeted. Operating expenses \$30,000 less than budgeted. Ending balance over \$100,000 more than budgeted and significantly outside the recommended fund balance guidelines. Plan to use up some of that fund balance within next year.

Brandi: want to look at fund balance in January with Finance Committee.

Jeff: significant impact of inflation on sales tax, expect to see increased receipts due to inflation. Probably will have more revenue than expected.

Stephanie: fund balance range is narrow.

Brandi: this type of organization does not have responsibility to deal with emergencies, concern about overtaxing membership. If we budget appropriately with auditors or legal, we shouldn't have to lean on fund balance to cover expenses.
