Fireweed is an iconic flower of Alaska, so endeared it is called "Alaska's Summer Clock" because of the long bloom and seed season, which tapers out shortly before the snow starts flying. In early summer, the flowers begin to bloom from the lower stem and progress up the stalk throughout the following months. The flowers then turn to cotton-like seeds. As the saying goes: "when fireweed turns to cotton, summer will soon be forgotten." Right now, most of our fireweed has turned to cotton, and we turn our attention the upcoming fall. According to the clock, the snow will start in about six weeks!

Alaska PFD



Alaskans will receive their Permanent Fund Dividends (PFD) in early October. The PFD is an annual dividend paid to Alaskan residents from investment earnings of mineral royalties. This year's PFD is \$1,312. Alaskans use their PFD to buy essential items such as food, fuel, and housing. We also use it to pay medical bills, credit card debt, purchase equipment, and travel. Purchases can extend to remote shopping and there may be a bump for Alaskan sales over the next few months!

Alcoholic Beverage Tax Lines

Eight Alaska communities have a separate tax on alcoholic beverages. Depending on the community, the tax will be in addition to the regular sales tax or it can be in lieu of the sales tax. For remote sellers, this affects primarily beer and wine clubs. Reporting on the alcoholic beverage tax lines should only be for alcohol sales. Numerous businesses report sales on the Anchorage Alcoholic Beverage line when they are clearly not in the business of selling alcohol. Anchorage does not have a regular sales tax, so only beer and wine clubs should report for Anchorage. Check your filings and contact us if you need to amend.









Sales Tax Updates

City of Homer and Kenai Peninsula Borough seasonal sales tax exemption for non-prepared foods effective 9/1/23.

City of Ketchikan seasonal sales tax rate of 3% effective 10/1/23.

City of Old Harbor adopted the remote sales tax rules effective 9/1/2023.

City of Seldovia seasonal sales tax rate of 2% effective 10/1/23.

City Borough Sitka will have a sales tax holiday on 11/24 and 11/25/2023.

City of White Mountain adopted the remote sales tax rules effective 7/1/2023.

ARSSTC Meetings Open to Public

The ARSSTC is comprised of member communities and our communities receive a quarterly update regarding the sales tax collection. The member communities also elect a Board of Directors and the Board meets virtually every six weeks. Both the quarterly update to member

Digital Goods are Taxable

All digital goods and services delivered into ARSSTC jurisdictions should be assessed sales tax (following tax-exempt rules for entities). Digital goods and services include the categories listed below. The ARSSTC has clarification regarding digital goods which can be found here: 2021.03 Digital Goods and Services. The interpretation states that if a product or service is transferred electronically, the buyer's billing address is to be used as the point of delivery to determine the appropriate sales tax rate.

- Software downloads
- Specified digital products
- Access to cloud-based software (SaaS)
- Streaming services
- Subscription based access to the above
- Other online or digital services

Account Balances

The ARSSTC has implemented a new policy regarding credit balances. If a business accrues credit due to amended returns, over-payments, or double payments, the ARSSTC will inform the business to use the credit with the next filing. If a business does not use the credit, ARSSTC will refund the credit back to the company via ACH Credit or physical check payment. Balance owed should be paid within 30 days to prevent further action. More information about actions for delinquent balance-owing accounts will be forthcoming.
