A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF THORNE BAY,
AMENDING RESOLUTION 10-05-18-01, 09-01-06-03, AND 12-06-19-01 WATER
AND SEWER RATE SCHEDULE FOR THE MUNICIPAL-OWNED WATER AND
SEWER UTILITIES

WHEREAS, the City Council is the governing body for the City of Thorne Bay, Alaska;
and

WHEREAS, Title 13 of the Thorne Bay Municipal Code provides that rate and/or hookup
fees for each of the municipal owned utilities shall be as set forth in the most current Rate
Schedule adopted and approved by resolution of the City Council and shall be
incorporated into Title 13 by reference;

WHEREAS, all seniors receiving the Senior Discount for utilities prior to March 19,
2013, will be "Grandfathered" and will continue to receive the discount; and


WHEREAS, the existing grandfathered customers will lose their grandfather status and

lack of payment.
